SUMMARY OF RESPONSIBILITIES:

• Upholds the Christian Science Manual By-law for Christian Science Nurse (Article VIII, Section 31).

- Serves as a Part-time Christian Science Nurse, or Substitute, for the Broadview Visiting Christian Science Nurse Service (BVCSNS) providing in-home Christian Science nursing care to patients in the Central Coast and Valley, including Ventura, Santa Barbara, and Bakersfield.
- Reports to and stays in close communication with the Director
- Follows through with all procedures as stated in the Policies and Guidelines

ESSENTIAL FUNCTIONS:

- 1. Gives daily specific metaphysical support to the BVCSNS
- 2. Works harmoniously with other BVCSN's
- 3. Receives and processes patient inquiries
- 4. Visits patients in their homes as directed
- 5. Contributes to the on-going assessment of patient needs
- 6. Maintains a high standard of Christian Science nursing
- 7. Works harmoniously with the Executive Director in the operations of BVCSNS when asked to do so
- 8. Communicates with the Business Office when needed
- 9. Maintains contact with patient families and practitioners as needed

OTHER FUNCTIONS:

- 1. Attends Christian Science nursing in-services, guidance training, and seminars
- 2. Understands and is able to execute the Google Doc account for the BVCSNS
- 3. Proficient in the operation of the answering service utilized for receiving patient calls.
- 4. Follows through with and catalogs all necessary paperwork and sends or gives it to the Director or office as needed
- 5. Is familiar with Broadview's Personnel Handbook and the BVCSNS Job Description
- 6. Alerts the Director in advance if needing time off
- 7. Fills in and covers for the Director when called upon to do so
- 8. Works closely with the Director on scheduling issues
- 9. Works closely with the Director with regards to patient care, and all other operations within the BVCSNS

WORKING CONDITIONS:

- 1. Is responsible for the car keys, Gas cards, GPS, and Tollroad Transponder which are provided by Broadview
- 2. Transporting patients is prohibited and no other driver is allowed, except in out-ofthe- ordinary situations
- 3. Must have a current and valid driver's license at all times
- 4. Carries and maintains a nursing bag which accompanies the CSN into homes. This bag is stocked as the CSN sees fit
- 5. The nursing supplies kept in the Broadview vehicle must be kept organized and clean
- 6. Keep the Director informed of any job(s) held outside of Broadview
- 7. This Job Description does not list all the duties of the job. You may be asked by the Director or Board of Directors to perform other instructions or duties. You will be evaluated in part based upon your performance of the tasks listed in the Job Description
- 8. Is given a Performance Review once a year
