

A Rule for Everyone

The "Rule for Motives and Acts" is based upon a <u>fuller</u> understanding of divine Science than a mere edict would imply. Understanding and acknowledging this Science heightens the utility and influence of the "Rule." Always require that it be followed mentally as well as outwardly. Subordinate human will to God's wisdom and power. Everyone and every institution is already under God's guidance and therefore must be included in the admonition the "Rule" counsels. No one is outside of this Science.

All being is mental and spiritual – that fact constituted the double mantle of Elisha. It represented the basis for his dominion over so very much of his experience. And it is the essence of man's God-given dominion over the whole earth. Know that you have this mantle spiritually and that it is understood and applied through divine Science.

Recognize the operation of divine Principle in human consciousness. Individuality belongs to God and always exists. There is no individual human consciousness. Therefore, it is necessary to see that our fellow man is innocent of the belief that he is a cause or a creator – that is, innocent of the belief that he is a creator of sin. Sin, not man, creates the sinner, and that only in belief. But the belief in sin must be destroyed in order that sin itself may also be made unreal because untrue. Understood innocence and forgiveness combine to give their full and proper aspects.

False influence is an inherent aspect of mortal consciousness until human will unsubordinated to Truth, God, disappears. "In reality there is no mortal mind, and consequently no transference of mortal thought and will power." (S&H)

Influence must be spiritualized through divine, scientific metaphysics. No one is outside of divine Science or its laws. Only in belief is there a separation. It's just

the belief of separation from the Science of being and therefore from God, good, that pretends the reality of a false influence.

Real identity cannot be lost or interfered with by human will operating as amalgamated thought-belief in the form of erroneous influence. God's action goes on eternally. Real being is Spirit and spiritual.

To put everyone and every institution under this "Rule" and leave the outcome to God is scientific and practical. Doing so eliminates any supposed need for human will apart from Truth, Life, and Love as these represent divine Principle. They are non-sensuous and provide the true sense of brotherhood and Christly charity in spiritual unity and oneness First establishing *in thought* the "Rule for Motives and Acts" as your own, you will naturally include others and their divinely directed modes of operation.

The "Rule" is given to all mankind since it operates through divine Principle governing "all that is real, harmonious, and eternal." (S&H) It is scientifically spiritual and is the expression of omnipotence, omnipresence, and omniscience or Spirit, God.

There is now no further allowance in divine Science for deviation in mental and spiritual approach or in human will from the operation of divine Principle. Christian Scientists are a law to themselves, not to injure, dominate, or control others but to do justly, wisely, and lovingly only as God directs. They recognize the light of Truth thrown upon the human concept and humbly follow the behests of Truth without false judgement, self-conceit, or hidden agenda. They "pause, wait on God" knowing that very *pause* represents not time or space, but a higher humility, with faith leading to spiritual understanding where mortal mindedness disappears and man in God's image and likeness appears. "Wisdom, purity, spiritual understanding, spiritual power, love, health, holiness" (S&H) are attributes of God and appear as guideposts in the application of the "Rule."

Erroneous influence naturally and completely disappears as a consequence of spiritual understanding.

Wonderfully, the perception of the "Rule for Motives and Acts" through the lens of divine Science finds the divine Principle, or God, operating everywhere and without abatement. It's a rule for everyone!
